This Memorandum of Understanding ("MoU") is entered into on 2nd January 2024 between:

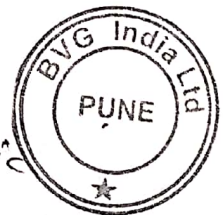







Article 6: Amendments
